

## 2022 Merrimack County Savings Bank "Dog Days of Summer" Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

**SPONSOR:** The Merrimack County Savings bank ("the Merrimack") "Dog Says of Summer" sweepstakes is sponsored by Merrimack County Savings Bank (Sponsor), PO Box 2826, Concord, NH 03302-2826.

**SWEEPSTAKES PERIOD:** The Merrimack's "Dog Days of Summer" sweepstakes begins at approximately 8am Eastern Time ("ET") on Monday, July 11, 2022 and the submission period ends at approximately 5pm ET on August 12, 2022. Photo submissions received after 5pm ET on August 19, 2022 will be deemed ineligible to be chosen as a top five (5) finalist. An internal judging committee will select the top five (5) finalists. The five (5) finalists will be contacted between 8am ET and 5pm ET during the week of August 22, 2022. Imagery submitted by the five (5) finalists will be posted on the Merrimack's Instagram page (@MerrimackStyle) for public vote before 5pm on August 29, 2022. A winner will be announced before 5pm on September 8, 2022. If the finalist with the highest number of likes does not respond to the Sponsor's contact attempts by 5pm ET on September 6, 2022, the finalist with the second highest number of votes will be named the winner.

**PRIZE:** The sweepstakes winner will receive a \$500 cash prize and a \$500 donation in their name to a registered 501(c)(3) animal rescue nonprofit of their choice located in either Merrimack County or Hillsborough County of NH. The Bank will reserve the issuance of cash payment until selection of a registered 501(c)(3) animal rescue nonprofit located in either Merrimack County or Hillsborough County of NH is provided.

**AGREEMENT TO OFFICIAL RULES:** By participating in the Merrimack County Savings Bank "Dog Days of Summer" sweepstakes, each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. The sweepstakes is subject to all federal, state and local laws and regulations and is void outside the United States and wherever prohibited by law. Prizes may be subject to tax; all applicable taxes are the responsibility of the winner.

**ELIGIBILITY:** The Merrimack County Savings Bank "Dog Days of Summer" sweepstakes is open to individuals who (a) are legal residents of New Hampshire. The contest is open to all NH community members with a Merrimack #MerrimackStyle bandana, which can be picked up at any of the Bank's seven branches in Concord, Bow, Contoocook, Hooksett and Nashua. (b) are at least eighteen (18) years of age at the time of entry. Employees of New Hampshire Mutual Bancorp and its subsidiaries are not eligible to participate in this contest. Sponsor has the right to verify the eligibility of each entrant before any prize is issued.

**ENTRY:** Entries for photo submissions must be of pets wearing #MerrimackStyle bandanas. Submissions will only be accepted electronically and may be emailed to <a href="mailto:merrimackmarketing@themerrimack.com">merrimack.com</a> or posted to Instagram, while tagging @MerrimackStyle and hashtagging: #merrimackstyle #merrimackdogdays. Electronic submissions through email must be in either JPG, TIFF, PNG or EPS format.

Mechanically reproduced or potentially fraudulent entries, as determined by Sponsor in its sole discretion, will be discarded.

- 1. Assignment of Publication Rights. We cannot, by law, publish any photographs on our website, social media pages, or in other publications without the explicit permission of the photographer. - Digital photography must be at a minimum resolution of 300 DPI at 10"x8" or 8"x10".
- Photographs with slightly lower resolutions will be reviewed, but may be rejected. Full color images require higher resolutions to produce acceptable results.
- Digital images must be saved in JPG, TIFF, PNG or EPS format.
- Merrimack County Savings Bank reserves the right to color correct and/or crop photo entries if necessary.
   Please do not submit a photo that contains a watermark on the image.

No payment or purchase is necessary to enter or win. A payment or purchase will not improve your chances of winning. Void where prohibited by law.

**DISQUALIFICATION:** Entrant may be prohibited from participating in this Sweepstakes if Sponsor, in Sponsor's sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest entrants or associated individuals or agencies. Limited to ten (10) pet photos per pet submitted per entry, with a limit of five (5) pet entries per person. Only one (1) pet photo will be chosen for public vote among the individual entry of pets that make the final top five (5).

The five (5) finalists will be chosen by the Sponsor's internal selection committee and will be contacted between 8am ET and 5pm ET during the week of August 22, 2022. Imagery submitted by the five (5) finalists will be posted on the Merrimack's Instagram page (@MerrimackStyle) for public vote before 5pm on August 29, 2022. A winner will be announced before 5pm on September 8, 2022.

**WINNER NOTIFICATION:** The Merrimack will contact the finalist with the highest number of Instagram likes by or before 5pm ET on September 6, 2022. If the Bank is unable to reach the winner after three (3) attempts or if the winner has not contacted the Bank within 30 days of announcement, another winner will be selected in accordance with official sweepstakes rules. The Merrimack will confirm the identity, age, and residency of winner before prize is awarded. The Bank will reserve the issuance of cash payment until selection of a registered 501(c)(3) animal rescue nonprofit located in either Merrimack County or Hillsborough County of NH is provided.

**ODDS OF WINNING:** The odds of winning are dependent upon the total number of eligible entries received.
