

## 2023 Merrimack County Savings Bank "A Few of Our Favorite Things – Windham" Sweepstakes Official Rules

## NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

**SPONSOR:** The Merrimack County Savings Bank ("The Merrimack") "A Few of Our Favorite Things - Windham" sweepstakes is sponsored by The Merrimack (Sponsor), PO Box 2826, Concord, NH 03302-2826.

**SWEEPSTAKES PERIOD:** The Merrimack's "A Few of Our Favorite Things - Windham" sweepstakes begins at approximately 8am Eastern Time ("ET") on Tuesday, October 17, 2023 and the submission period ends at approximately 5pm ET on Monday, October 30, 2023 (such period, the "Sweepstakes Period"). Entries received after that date will be deemed ineligible to win.

**PRIZE:** There is one (1) prize to be won. The winner must go to The Merrimack branch in Windham (1B Wall Street, Suite 106) to collect the prize won. If a winner does not claim their prize within five (5) days of notification, another eligible entry will be selected and contacted and the first selected entrant will have no further claim to the prize. Sponsor will not mail or courier the prize and is not responsible for unclaimed prizes.

**ENTRY:** To enter the Sweepstakes and be eligible to win a prize, visit The Merrimack branch in Windham (1B Wall Street, Suite 106) to enter in-person or visit The Merrimack's official Instagram page (@MerrimackStyle), then read and follow the Sweepstakes rules. To participate via Instagram, the entrant must like our post and tag at least one (1) friend in the comment section. Each entrant may spread the word and tag four (4) more friends to receive additional entries, five (5) entries in total.

**WINNER SELECTION:** The winner will be chosen by random draw, which will take place on Tuesday, October 31, 2023. The winner will be announced on each of the eligible platforms on Tuesday, October 31, 2023 through an announcement on the social media site by a representative of the Sponsor. The Sponsor will also direct message the winner to notify them of their winning. The winner must reply within forty-eight (48) hours to maintain eligibility. If a potential winner cannot be contacted within this time period, such potential

winner will be disqualified, their entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.
