“A Few of Our Favorite Things – Henniker” Sweepstakes Rules & Regulations

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The Merrimack County Savings Bank (“The Merrimack”) “A Few of Our Favorite Things - Henniker” sweepstakes is sponsored by The Merrimack (Sponsor), PO Box 2826, Concord, NH 03302-2826.

SWEEPSTAKES PERIOD: The Merrimack’s “A Few of Our Favorite Things - Henniker” sweepstakes begins at approximately 8am Eastern Time (“ET”) on Monday, September 16, 2024 and the submission period ends at approximately 5pm ET on Friday, September 27, 2024 (such period, the “Sweepstakes Period”).

PRIZE: There is one (1) prize to be won on Instagram. The winner must go to The Merrimack’s Henniker branch on 262 Maple Street to collect the prize. If a winner does not claim their prize within five (5) days of notification, another eligible entry will be selected and contacted and the first selected entrant will have no further claim to the prize. Sponsor will not mail or courier the prize and is not responsible for unclaimed prizes.

ENTRY: To enter the Sweepstakes and be eligible to win a prize, visit The Merrimack’s qualifying social media site – Instagram (@MerrimackStyle), then read and follow these Sweepstakes rules. To participate, the entrant must like our post on The Merrimack’s Instagram (@Merrimackstyle) page and tag at least one (1) friend in the comment section. Each entrant may spread the word and tag four (4) more friends to receive additional entries, five (5) entries in total.

WINNER SELECTION: The winner will be chosen by random draw, which will take place on Monday, September 30, 2024. The winner will be contacted by a representative of the Sponsor via direct message, followed by an announcement on Instagram. The winner must reply within forty-eight (48) hours to maintain eligibility. If a potential winner cannot be contacted within this time period, such potential winner will be disqualified, their entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.
